Delivered the following graduate level distance courses; Introduction to Public Administration, Public Budgeting and Financial Management, Public Organization Management, Organizational Leadership, Public Policy Analysis, Environmental Justice, Environmental Policies and Practices, Elements of Sustainability and Livable Communities, Tools for Sustainable Development, Strategic Planning for Sustainability, and Digital Government.

COURSES TAUGHT

- 9/97-Present Environmental Justice (Undergraduate/Graduate Level, online& In-person)**
This course is designed to provide students with an introduction and overview to environmental justice. The course covers topics such as the history and development of the environmental justice movement, the distribution of environmental pollution across populations of minority and low-income communities, environmental risk, economics of the environment, and finally the environmental policy making process.
- 1/99-Present Introduction to Public Administration (Graduate/Undergraduate, online & In-person)**
This course provides students with an introduction and overview to the foundations of public administration. Students are exposed to the historical development of public administration and the main contributors to the field from 1887 to the present. The course also addresses the factors that have shaped the direction of public administration, leading to its current state.
- 1/00-Present Public Policy Analysis (Graduate/Undergrad., online & In-person)**
This is a required course for all graduate public administration students. The course focuses on the evolution of public policy. Additionally, students are taught how to conduct a policy analysis using both quantitative and qualitative approaches. The course also incorporates tools used to perform a policy evaluation.
- 1/97-Present State and Local Government (Undergraduate Level)**
This course is designed to introduce students to the structure, powers, function, and problems of state and local government and their role in the federal system. Students examine, assess, and evaluate state and local governmental policies, practices, institutions, and citizen involvement. . A

review of intergovernmental relations and a distinction between each level of government was a large part of the course.

8/23-12/23 Ethics (Undergraduate Level)

Ethics – examines the historical and philosophical development of ethics with particular attention to the moral implications of contemporary ethical problems and prospects for solutions. Emphasis is placed on the process of decision-making as it relates to the question or issue. The elements of professional ethics examined and discussed in the course are applicable to professions in public, private and non-profit organizations alike, which make them essential for exploring the role of personal and professional values and ethics in various settings.

8/97-8/23 Public Organization Management (Graduate Level, online)

This course provides students with a firm understanding of the distinction between organization theory and behavior. Luminaries in the field of organization theory and behavior and their contributions to the field are discussed. Student case studies of current public organizations provide a clear understanding of the different characteristics of public and quasi-public organizations. Images and metaphors are used to illustrate the distinguishing characteristics of public and quasi-public organizations.

5/19-8/23 Environmental Policies and Practices (Graduate Level, online)

This course provides an overview of current environmental policies and practices at the federal, state, and local level as well as global environmental issues. Topics covered are: sustainable development, resiliency; environmental risk, economic environmental issues; and the distributed effects of environmental pollution across ethnic, racial, income and occupational groups.

8/21-8/23 Elements of Sustainability and Livable Communities (Graduate, online)

The course focuses on formation and preservation of sustainable, healthy communities, the importance of leaders who understand the relationships between natural, built, and social environments, and the need to maintain these connections in holistic and integrative ways. Students learn the concepts of sustainability and healthy living, and explore methods used to create and maintain communities working to become environmentally, economically, and socially resilient and equitable. The course also explores ways to manage urban growth or shrinkage and promote alternative means of transportation, food production and access, affordable-safe housing.

5/21-8/23 Strategic Planning for Sustainability (Graduate, online)

Introduces students to skills needed for effective community leadership including tools, strategies, and skills needed when overseeing the creation and maintenance of sustainable communities. Students explore the fundamentals of strong leadership when building the capacity for community adjustments; assessing community needs, resources, and problems; constructing a community vision based in overall health; encouraging constituent interest and involvement; and implementing practices that improve sustainability in communities. Sustainability theories and models are presented in the course and used in the overall analysis of community development.

1/21-8/23 Tools for Sustainable Development (Graduate, online)

Introduces students to skills needed for effective community leadership including tools, strategies, and skills needed for the creation of sustainable communities. Explores the fundamentals of strong leadership when building the capacity for community adjustments; assessing community needs, resources, and problems; constructing a community vision based in overall health; encouraging constituent interest and involvement; and implementing practices that improve sustainability in communities. Sustainability theories and models are presented in the course and used in the overall analysis of community development.

08/20-Present Organizational Leadership (Graduate Level, online)

This course focuses on the challenging role of leaders in today's complex organizations. Topics covered include change management, organizational dynamics, vulnerability, empathy, and crisis management.

- 5/06-08/10 Digital Government (Graduate Level, online)**
This course is designed to provide public, private, and non-profit managers with a core knowledge of the technology issues in public administration that are increasing in significance. It provides students an overview of major theories and concepts explaining the role and impact that technologies such as Social Media and the Internet have on organizations.
- 8/08-08/11 Public Budgeting and Financial Management (Graduate Level, online)**
This is a web-based course is designed to expose students to the theoretical foundations and applied practices of public budgeting and financial management of public organizations. The course focuses on the issues of budgeting and finance in a broad sense and as it pertains to public administration specifically.
- 8/07-08/08 Environmental Policy and Planning (Graduate Level online)**
This is an elective course for all graduate public administration students. The course focuses on the history of environmental policy and the evolution of the environmental movement. The environmental policy making process is examined. The course incorporates student debates of a wide variety of environmental issues.
- 8/99-08/08 Intergovernmental Relations (Undergraduate/Graduate Level)**
This is an elective course for graduate students. An overview of intergovernmental relations is provided as well as an in-depth analysis of the current issues facing public administrators at the state and local level. A review of recent journal articles on federal, state, and local government allows students to develop an understanding of recent scholarly writings in this field of study. Additionally, the roles of public administrators at the state and local level are examined from different viewpoints. *(This course was delivered both in the traditional classroom format and as a distance learning course at Florida Gulf Coast University).
- 1/99-08/08 Research Methods for Public Administration (Graduate Level)**
This is a core course for graduate students in the MPA program at Old Dominion University. Students are provided with the knowledge needed to conduct research in the field of public administration. The course provides students with exposure to a variety of research approaches including both quantitative and qualitative methods. Students learn how to design a research project, gather data, analyze and interpret the results.
- 9/06-08/08 Leadership (Graduate Level)**
This course is designed to expose students to the theoretical foundations and applied practices of leadership. The course focuses on the issue of leadership in the broad sense and as it pertains to public administration specifically.
- 8/99-5/04 Concepts and Issues in Public Administration (Undergraduate Level)**
This is a required course within the undergraduate public administration program at San Diego State University. The course provides students with an overview of the foundations and historical development of public administration. The course also examines the development of the field of public administration and the challenges facing public administrators today.
- 8/99-5/04 Administration and Public Policy Development (Undergraduate Level)**
This course provides students with an introduction to the public policy making process. The course covers the evolution of public policy, contemporary public policy issues, as well as factors that have shaped the direction of public policy.
- 1/98-7/99 Emerging Issues in Environmental Policy (Graduate & Undergraduate Level)**
This course is designed to investigate emerging trends in environmental policies including global climate change, conservation, sustainability, economics, energy policy, land use policy, and environmental justice. Environmental policies in these areas are examined from the legal, administrative, economic, legislative, and scientific perspectives. This course was taught at Florida Gulf Coast University and San Diego State University.
- 1/00-5/04 Public Administration Internship Coordinator (Graduate & Undergraduate Level)**
This position involves developing an extensive database of internship opportunities for graduate and undergraduate students, screening student applicants and monitoring students. Each student is evaluated at the end of each semester.

1/1-5/98**Grant Writing in Administration (Graduate Level, Team Taught Course)**

This is a graduate seminar and an elective course in the MPA program. The course is designed to provide students with a set of experiences which will enhance their ability to design, review and manage grants and/or research proposals in the public and social service sector. The primary goal of this class is to give students a basic understanding of program evaluation and grant writing methods and management, and a set of skills to assist in practical program management, and project assessment. Special emphasis will be placed on obtaining funding from private foundations and federal government agencies.

1/95-8/97**The Changing Environment of Business, Government and Society (Undergraduate Level)**

This course is designed to fulfill an AACSB accreditation requirement that undergraduate business majors complete course-work in social responsibility and ethics. This course is also required of all public administration majors at Florida Atlantic University. Taught from a public policy perspective, subjects covered include: public policy process, models and rulemaking; social responsibility and theories of justice; regulation of business and participation in the legislative and rulemaking environments; EEO and affirmative action; environmental regulation; and political rhetoric.
